IAOPA Board Approves Dues Restructuring

In an almost unanimous vote (130 yes, 1 no), the IAOPA Board has approved a dues restructuring initiative that will greatly simplify the calculation of the annual fees IAOPA affiliates are charged. The amendment, as approved, changes the calculation of the dues from Swiss Francs to US Dollars (USD), greatly simplifying the budgeting process while eliminating the current multi-tiered system. Under the new structure, affiliates with 1,000 members or less will pay a flat fee, currently set at \$350, while larger affiliates with over 1,000 members will pay a fee of \$.35 per member. All in all, the amendment, as adopted, reflects current billing practices, streamlines the accounting processes, and allows for necessary adjustments in the future to meet the budget requirements of the organization. There will not be any change in IAOPA's position advocating for general aviation on the world stage including the International Civil Aviation Organization (ICAO) and with regional bodies such as the European Aviation Safety Agency (EASA).

With the successful passing of the amendment, IAOPA Headquarters staff is currently in the process of generating the affiliate invoices for the calendar year 2015. All calculations are based on the last reported member count for all affiliates. It is crucial that this information is provided to IAOPA at least annually so that the invoicing process and the budgeting process accurately capture the state of the organization. New this year, invoices will contain an option for paying by credit card in addition to the standard check or bank transfer options. For more information, please contact IAOPA Headquarters.

IAOPA continued to gain strength in the international aviation arena from an increased membership base when the Board approved and welcomed AOPA-Argentina as the 73rd affiliate member. IAOPA staff continued an active membership campaign by providing affiliation information and guidance to interested pilot groups in throughout the globe.

Planning Underway for 2016 World Assembly Hosted by AOPA US

At the 27th IAOPA World Assembly last September, hosted by AOPA China, the board attendees unanimously voted to accept the proposal from AOPA US to host the 28th IAOPA World Assembly in 2016. Planning for the upcoming meeting is already underway.

As listed in the IAOPA Constitution and Bylaws, the IAOPA Board is required to meet every other year to

coordinate the views and opinions of member organizations with respect to proposed requirements, recommended practices, procedures, rules and facilities and services for international aviation. But more importantly, the World Assembly serves as a chance for all affiliates to come together and determine the work program and the future of the organization in a face to face gathering that builds on the spirit and purpose of IAOPA, protecting and defending the freedom of general aviation all over the globe.

A site survey team is scheduling a visit to the proposed host city, Milwaukee, Wisconsin to review possible venues, hotels and transportation arrangements. Milwaukee, which is located on the shores of Lake Michigan, is best known for its famous breweries but there is way more to the city than beer and baseball. Milwaukee is rich in historical and cultural attractions. It is close to Chicago with plenty of nonstop flights to and from around the world. More importantly, it is located an hour south of the mecca of all general aviation, Oshkosh, Wisconsin. Our planned date (July 22-24, 2016) will allow you to attend the IAOPA World Assembly and then stay on for as long as you like to visit EAA's AirVenture 2016 the week of 25-31 July, 2016.

FAA Provides Glimps of Licensing Annex to BASA

The FAA has posted on its website a draft of the Pilot Licensing Annex to the U.S.-EU Agreement on Cooperation in the Regulation of Civil Aviation Safety. The draft has been provided for informational purposes as the FAA is not seeking comment at this time. The initial scope of this draft annex covers private pilot licenses, and night and instrument ratings, in single-engine piston land airplanes and multi-engine piston land airplane categories in single-pilot operations, excluding type ratings. IAOPA applauds the FAA for making this information public and has committed to working with the FAA and EASA to ensure that the final document when published will improve safety and eliminate unnecessary and redundant requirements.

Subject to the terms of the draft annex, FAA private pilot certificates or instrument ratings would be issued to pilots who hold valid EU Part-FCL pilot licenses (with or without night ratings) or instrument ratings of corresponding categories and have demonstrated compliance with the applicable FAA Special Conditions.

Also subject to the terms of the draft annex, EU Part-FCL private pilot licenses (with or without night ratings) or instrument ratings would be issued to pilots who hold valid FAA pilot certificates or instrument ratings of corresponding categories, meet the applicable currency requirements, and have demonstrated compliance with the applicable EU Special Conditions.

To support the issuance of certificates or licenses under this draft annex, the NAAs and the FAA would be required to certify the authenticity of the pilots' original licenses or certificates. They would also annually share data regarding the licenses and ratings converted.

FAI Announces Location of 2021 World Games

The International World Games Association (IWGA) awarded the organisation of The World Games 2021 to Birmingham, Alabama, USA. This decision was announced by IWGA President José Perurena at a press conference in Lausanne, Switzerland, in the presence of FAI representatives.

Birmingham (USA), Lima (Peru) and Ufa (Russia) had presented their bids to host the 11th edition of the multi-sport event, the second largest after the Olympic Games.

"We are happy to showcase our sports in Birmingham in July 2021, and we are sure that we will be offered optimal conditions for our sportsmen and women there. All the bids we received were of very high quality, and it was not easy for us to reach a decision. We have to deliver nothing less than outstanding World Games. We are convinced that Birmingham will exceed these expectations." José Perurena stated.

The World Games are organised and governed by the International World Games Association, under the patronage of the International Olympic Committee (IOC). Air sports have been in the programme of The World Games since 1997. The next edition of the Games will take place in Wroclaw, Poland, in 2017 and will include Glider Aerobatics, Parachuting Canopy Piloting and Paramotors.

EASA Announces Senior Management Changes

The European Aviation Safety Agency (EASA) announces three key management changes following the new organization structure decided by its Executive Director Patrick Ky and announced on 1 September 2014.

Effective 5 January 2015, Luc Tytgat has been appointed by the EASA Management Board as Director of the newly created Strategy and Safety Management Directorate. In this role, Luc Tytgat will be in charge of raising safety intelligence as one of EASA's key priorities and developing a better and more agile regulatory framework. Prior to EASA, Luc Tytgat was the Director of the Pan-European Single Sky Directorate at Eurocontrol since 2011, after having worked for 20 years in the field of air transport and space at the European Commission and 10 years in the Belgian Air Force.

Effective 5 January 2015, Olivier Ramsayer has been appointed by the EASA Management Board as the new Resources and Support Director. In this role, Olivier Ramsayer will be in charge of simplifying, raising the efficiency and flexibility of EASA support services. Prior to EASA, Olivier Ramsayer was Head of Resources and Support Department at the European Food Safety Authority, after different managerial positions in the EU institutions.

Effective 1 March 2015, Trevor Woods, currently Flight Standards Director at EASA, will replace Norbert Lohl as Certification Director. In this role, Trevor Woods will address the new challenges faced by the Agency in the evolution of technologies and constraints on resources in the certification domain. Norbert Lohl will be retiring at the end of February 2015.

Wilfried Schulze, Deputy Director, will be acting as Flight Standard Director.

Patrick Ky declared: "The new organization shapes EASA for the next decade. The Management team is focused on one objective: develop, for the benefit of travelling passengers, the safest possible aviation regulatory system, in partnership with the European Commission and the Member States and in support of the growth of the aviation industry".

Olivier Ramsayer, Luc Tytgat, Trevor Woods and Wilfried Schulze are members of the EASA Executive Committee and report directly to Patrick Ky.

Could you handle a survival situation? Get the experts' tips on survival preparedness

You've just made an unplanned, off-airport landing. Thanks to your training you were able to calmly cope with a developing in-flight emergency and successfully land the airplane. But now what? Have you been adequately prepared for what happens next—how to reach out for rescue and endure the elements until help arrives?

A little knowledge on what to do after a forced landing can go a long way. In the Air Safety Institute's [Survive: Beyond the Forced Landing video](#) and [safety advisor](#) aviation experts share what actions you can take to keep you and your passengers safe until help arrives. Among their advice are tips on survival kit essentials and how you can reduce the time it takes to get found. You learn why you and your passengers should be dressed to match the climate and terrain you will be overflying to be prepared for conditions other than those expected at your departure and arrival points.

As you might imagine, increasing your chances of a post-crash survival start with proper flight planning. Watch *Survive: Beyond the Forced Landing* to learn about the single most important thing to do to
